1. Promotion period: from 1/24/2025 9:00 CEST to 2/16/2025 23:59 CEST.
2. Promotion territory: the territory of Ukraine within the internationally recognized borders, except for the temporarily occupied territories of Ukraine and areas of armed conflict.
3. Promotion place: the <http://supergra.ua> website (hereinafter referred to as the Portal) and/or the SuperGra Mobile Application (hereinafter referred to as the Mobile Application).
4. The prize pool of the Promotion: the total prize pool is 2 000 000 EUR, which is divided among 10 000 Mystery Boxes. There are 10 000 Mystery Boxes in total. Each of them can contain one of the following cash prizes: the equivalent of 200 EUR in UAH; the equivalent of 50 EUR in UAH; the equivalent of 20 EUR in UAH; the equivalent of 10 EUR in UAH; the equivalent of 5 EUR in UAH.
5. The list of gambling games participating in the Promotion: all games by the VoltEnt provider.
